Perhaps Temple Sholom is your source for connection to the Jewish community, Jewish culture and to community service. Perhaps it is where you join with people who support and comfort each other in their good times and challenging times. Or maybe it is where you join with young people and adults for educational opportunities about Jewish heritage and values. Maybe it is where you go for celebration of lifecycle events. Or maybe it is where you experience meaningful worship as part of a larger community.

Temple Sholom means many things to many people. But Temple Sholom would be nothing without the dedicated support of the members of our community.

Temple Sholom, a healthy, growing congregation

In 2015 Temple Sholom had 75 member families, this year we now have 131 member families, an increase of 75%. This growth is even more remarkable in an environment of low growth and sometimes declines in membership in many synagogues. There are many reasons for this long term success: our superb clergy team, our open High Holiday services, our Hebrew program and our excellent Jewish Journeys program. However, as important as these elements are, it is the commitment and support of our incredible membership that makes all of this possible.

An important aspect of community support is your financial contribution.

Temple Sholom has always relied upon our endowment funds to heavily subsidize our dues to support our extensive programming. However, at our current rate, our endowment funds will not last forever. Your financial contribution is critical to our continued success.

Your Conscientious Contribution. Several years ago Temple Sholom implemented a new contribution model to replace our previous dues model. The new model, called a Conscientious Contribution, requires each member to pledge an amount that, in the member's good conscience, helps support the congregation in an affordable way. Unlike under a traditional dues policy no member will ever be required to petition for reduced dues, no member will ever be asked to submit documentation of earnings, and nobody will be asked to explain extenuating circumstances. All we ask is that all members look deep within their hearts to consider the value of Temple Sholom to themselves and the community and to determine what each of us can do to support the congregation. In order to receive full membership rights and privileges at Temple Sholom a pledge, regardless of amount, is required.

Guidelines and Suggestions:

What would be a generous Conscientious Contribution amount?

Under the previous dues model, the suggested contribution amount was **\$195 per month or \$2340 per year**. This level of support would be very generous and greatly appreciated! If all of our members could contribute at this level, or close to it, we would be able to cover our operating expenses with minimal withdrawals from our long term endowment. Membership support at this level along with other donations would put Temple Sholom in an excellent financial position to continue all of its many services to our community.

Consider increasing your contribution

Please consider increasing your pledge level from last year's pledge amount. Even a 5% or 10% increase, which may represent only a few dollars a month to an individual member's contribution, can have a significant benefit upon the congregation. Every contribution helps to ensure a lasting legacy at Temple Sholom, so that we can continue to offer the community everything we have come to love and appreciate.
